ORDINANCE 2023-2

**AN ORDINANCE TO PROHIBIT PARKING ON CHURCH
STREET (500 FEET SOUTH OF SEVEN MILE FIRE
DEPARTMENT GARAGE ON BOTH SIDES OF STREET)
WITHIN THE VILLAGE LIMITS OF THE VILLAGE OF SEVEN
MILE, OHIO**

WHEREAS, the Council of the Village of Seven Mile, Ohio has had discussion regarding the need to adopt an Ordinance providing regulation of parking along Church Street within the Village of Seven Mile, Ohio.

WHEREAS, after such discussion, the Council of the Village of Seven Mile, Ohio has determined that it is necessary to prohibit parking along Church Street (500 feet south of Seven Mile Fire Department Garage on both sides of the street) to provide safe access for emergency vehicles to enter and depart the Fire Station, allow a safe traffic pattern and to promote the preservation of the public health, safety and welfare

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Seven Mile, County of Butler, State of Ohio:

Section 1. No person shall stop, stand or park any vehicle within 500 feet south of Seven Mile Fire Department Garage on both sides of the street on Church Street.

Section 2. That any violation of this ordinance shall be a minor misdemeanor. Each day of parking shall constitute a separate offense.

Section 3. If any section, subsection or clause of this Ordinance shall be deemed to be unconstitutional or otherwise invalid, the validity of the remaining sections, subsections, and clauses shall not be affected.

Section 4. This Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal actions, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

Section 5. This Ordinance shall take effect and be in full force from and after the earliest period allowed by law after its passage.

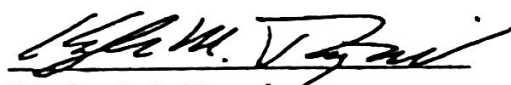
